OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims to generate positive total returns over a period of 5 years starting from 19th November 2019 (the "Principal Investment Period") by providing exposure to a diversified range of asset classes. The Sub-fund will invest in equities and equity related securities, debt securities, high yield corporate or government floating rate notes, currencies and cash. The sub-fund will invest in equities and equity related securities that may benefit from global long-term market themes resulting from secular changes in economic and social factors such as demographics, lifestyle, regulations or the environment.

The Sub-Fund is actively managed.

The Sub-Fund is suitable for investors who search medium term investments and the investor must be able to accept a certain volatility and the possibility of losing part of the invested amount. The Sub-Fund has been designed for investors who will invest in the Sub-Fund during the Initial Subscription Period and will hold their investment until the end of the Principal Investment Period (18th November 2024). The return forecasts may differ if the investor does not intend to hold the investment until the end of the Principal Investment Period.

The Sub-Fund may invest:

- up to 60% of its net assets in equities and equity related instruments (including depositary receipts such as ADR, GDR, EDR. ADR, GDR and EDR may include embedded derivatives and underlying will at any time comply with the eligibility criteria stated in the UCI Law and the Grand Ducal regulation dated 8 February 2008, as amended from time to time);

- up to 20% of its net assets in non-investment grade instruments;

- up to 10% of its net assets in distressed securities or defaulted securities;

- up to 30% of its net assets in instruments issued by entities located in emerging markets;

- up to 10% in China A-Shares via the Shanghai-Hong Kong Stock Connect program;

- up to 20% of its net assets in UCITS and/or other UCIs, including ETFs (in the above mentioned asset classes);

- up to 10% of its net assets in money market instruments and cash.

The Sub-fund may invest without limitation in instruments denominated in currencies other than the reference currency (EUR). The non-EURO currency exposure will not exceed 50% of the Subfund's net assets.

The Sub-fund will not invest in ABS nor in MBS nor in CoCos.

The Sub-fund may use financial derivative instruments for investment and for risk hedging purposes.

During the Initial Subscription Period (from 1st October 2019 to 18th November 2019) the Sub-Fund will hold 100% of its net assets in cash denominated in Euro.

Once the terms of the Principal Investment Period have expired, there will be progressive investment seeking to consolidate the performance achieved.

The Sub-Fund is not managed in reference to a benchmark.

Share Class R is capitalization Share-Class. For Share-Class S, the net incomes of the Sub-Fund will be distributed in accordance with the Prospectus of the Fund.

You may request to redeem the shares held at any moment, by sending a request on any business day.

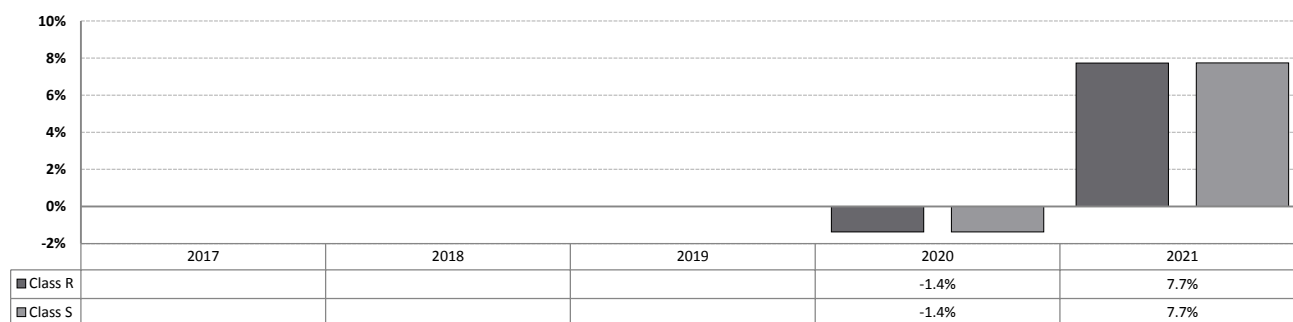

The **entry and exit fees** shown in the chart will be applied from 19th November, 2019 to 18th November, 2024. They are maximum figures as they decrease during such period. You can find this out from your financial adviser or from the distributors. The ongoing charges figure is based on expenses for the year ending **31/12/2021**. This figure may vary from year to year. It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit fee paid by the Sub-Fund when buying or selling units in another fund. The ongoing charges figure include the amortization (over 5 years) of a placement fee corresponding to 2.00% of the initial Net Asset Value per share (EUR 10).
