OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims to provide a positive return, defined as a mix of income and capital growth, while actively managing total portfolio risk and providing dynamic exposure to a diversified

range of asset classes. The Sub-Fund is suitable for investors who search medium term investments and the investor must be able to accept a certain volatility and the possibility of losing part of the invested amount. The overall portfolio of the Sub-Fund is intended to have an annual targeted volatility level of 3-9% per annum but may be lower or higher depending upon market conditions. The Sub-fund will invest in securities issued by corporations, other non-government issuers, governments and government related issuers located in both developed and emerging markets and denominated in global currencies. The Sub-Fund will not have any restrictions in selecting securities in terms of industry or geographical allocation. The Sub-Fund may invest:

- Up to 100% of its net assets in fixed-interest and floating rate securities;
- securities; up to 50% of its net assets in equity instruments, including depositary receipts (such as American depository receipts "ADRs", European depository receipts "EDRs" and global depository receipts "GDRs"); up to 30% of the net asset value in government bonds, corporate bonds (investment grade and non-investment grade) and equity instruments issued by entities located in Emerging Markets; up to 40% of its pat asset in China A Sharas via the Sharabaja
- up to 10% of its net assets in China A-Shares via the Shanghai-Hong Kong Stock Connect program and debt securities issued by Mainland China issuers through Bond Connect program;
- up to 20% of its net assets in non-investment grade instruments (including non-investment grade debt securities issued by emerging market issuers);

In aggregate, and accounting for active currency positions as described, the non-EURO currency exposure will not exceed 50% of the Sub-fund's net assets. The Sub-Fund may use financial derivative instruments for the purpose of investment and risk hedging. The Sub-Fund will not enter into total return swaps nor in repurchase or reverse repurchase agreements. The Sub-Fund is not managed in reference to a benchmark. The Sub-fund is actively managed

With reference to the Unit-Class S, the net incomes of the Sub-Fund will be distributed in accordance with the Prospectus of the Fund. On the base of the NAV computed on April 21, 2022 as of April 20, 2022, the assets of unit class R will be automatically transferred to unit class R1 and the assets of unit class S will be automatically transferred to unit class S1. to unit class S1.

You may request to redeem the units held at any moment, by sending a request on any business day.

CHARGES


