OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims to prudently generate a total return through a combination of both income and capital growth. The Sub-Fund invests in a wide range of fixed income securities (which are loans that pay a fixed or variable rate of interest) issued by companies or governments from around the world. Securities will mainly be priced in US Dollars but the Sub-Fund may also hold other currencies as well as securities that are priced in other currencies. The investment advisor will choose securities with varying repayment dates based on its expectations for interest rate and exchange rate changes. The Sub-Fund may invest in emerging markets, which in investment terms are those economies that are still developing.

The securities will mostly be "investment grade", as determined by international ratings agencies. Whilst potentially producing a lower level of income than "non-investment grade" securities, they are also considered to be of lower risk.

For the attainment of its objective, the Sub-Fund's assets may be invested in mortgage backed securities (MBS), commercial mortgage backed securities (CMBS), asset backed securities (ABS) and

securities equivalent in nature to such securities. Investments in such securities carry the risk of default of the underlying collateral.

The Sub-Fund may invest in contingent convertible bonds ("CoCos")

up to 10% of its net assets.

The Sub-Fund is covered against the exchange rate risk by a hedging strategy on currencies.

The benchmark of the Sub-Fund consists of the index "Bloomberg Barclays US Aggregate Index" Total Return, Hedged in EUR.

The Sub-fund is actively managed and the degree of freedom allowed

within the management of the sub-fund is significant. The relative risk and positioning to the benchmark is monitored. To provide a disciplined management approach, risk limits are set to contain investment risk. This may impact the extent to which the composition of the portfolio and it's performance deviate from that of the


