## OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims to preserve capital and provide a stable growth investing globally in equities, bonds (including bonds convertible in equity shares) and money market instruments denominated in various currencies in anticipation of up and down movements.

Assets will typically consist of equity related securities and debt securities.

The Sub-Fund may be exposed to other currencies than the base currency through investments and/or cash holdings.

The Sub-Fund will use the currency exposure actively in the investment strategy.

The Sub-fund may invest up to 10% of its Total Assets in Mortgage Backed Securities (MBS).

The Sub-Fund will not invest in Contingent Convertibles (CoCo), distressed securities, default securities nor asset backed securities (ABS)."

The Sub-Fund may use financial derivative instruments mainly to:

- protect itself against the depreciation of foreign currencies in its portfolio;

- mitigate the negative effect related to the default of the issuer(s) of debt instruments in its portfolio;

- take additional credit risks against the regular receipt of premium payments from the counterpart who benefits from the protection;

- extend or reduce its duration; or

- replace a direct investment in securities.

Some of these derivatives' strategies may significantly increase risks. Investment in the Sub-Fund may be suitable for investors with a medium term investment horizon.

The Sub-Fund is actively managed.

The Sub-Fund is not managed in reference to a benchmark.

This Sub-Fund has three Unit-Classes: Class R, S and T.

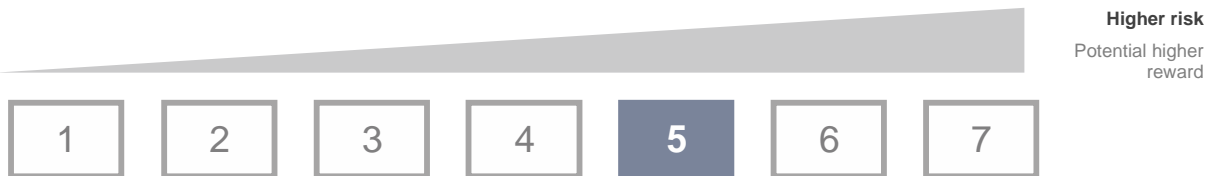
R and T are capitalization Unit-Classes. With reference to the Unit-Class S, the net incomes of the Sub-Fund will be distributed in accordance with the Prospectus of the Fund.

- **Credit risk:** The Sub-Fund invests in securities whose credit rating may get worse, increasing the risk that the issuer is unable to fulfil its commitments with a negative impact on the securities' price.
- **CoCo risk:** Investments in CoCos may expose the Sub-Fund to different risks, the main ones being: Conversion risk, Write down, Coupon Cancellation, Call extension risk, Capital structure inversion risk, Industry concentration risk (as described in the Prospectus).
- **Liquidity risk:** The Sub-Fund invests in markets that can be characterized by a reduced possibility to exchange securities without a negative impact on prices.
- **Counterparty risk:** The Sub-Fund invests into instruments, such as derivatives, by entering into contracts with financial counterparties, exposing itself to the risk that said intermediaries may generate financial damage to the fund itself by not fulfilling their obligations in the future.

## CHARGES

These fees and charges are used to pay the costs of running the Sub-Fund, including the costs of marketing and selling. They reduce the potential growth of your investment.

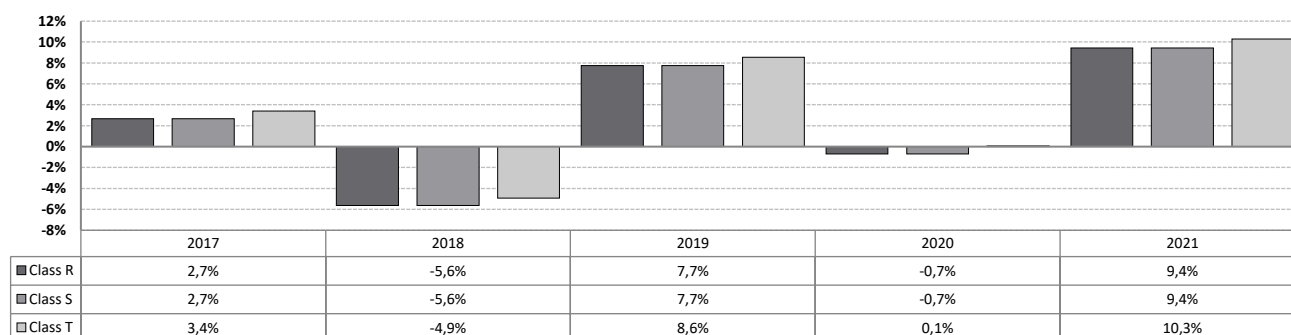

The **entry and exit fees** shown in the chart are maximum figures. In some cases you might pay less. You can find this out from your financial adviser or from the distributors. For the switch of units, you may choose alternatively two systems of fees: the tariff "by transaction" and the tariff "fixed" (applied on a quarterly basis on the capital invested). The **ongoing charges figure** is based on expenses for the year ending on **31/12/2021**. This figure may vary from year to year.

It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit fee paid by the Sub-Fund when buying or selling units in another fund.
