OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims at providing stable returns by investing primarily in investment grade short term securities issued by government and/or non governmental entities, with a flexible approach. The average portfolio duration of this Sub-Fund will not exceed four years. For the purpose of the Sub-Fund, debt securities will not have a residual maturity exceeding seven years.

The positioning of the Sub-fund in terms of duration and credit sensitivity would fluctuate, over the cycle, between two strategies: the low risk strategy, which is more defensive, and the neutral strategy, with longer maturities, higher interest rate and credit risks sensitivity.

These securities may include, but are not limited to: corporate debt securities, bonds, fixed and floating rate securities.

The Sub-Fund may residually invest in securities denominated in currencies other than the reference currency of the sub-fund (EURO) and securities issued by entities domiciled in emerging market countries. The currency exposure will be

hedged back into EURO. The Sub-Fund may also hold deposits. Moreover the sub-fund may invest in money market instruments up to 10% of its net assets.

The Sub-Fund may use financial derivative instruments not only for the purpose of risk hedging and efficient management but also for investment purposes. The Sub-Fund is suitable for investors who search short term investments.

The Sub-Fund is not managed in reference to a benchmark.

The Sub-Fund is actively managed.

The Sub-Fund does not fall within the scope of Regulation (EU) 2017/1131 of the European Parliament and of the Council of 14/06/17 on money market funds.

This is a capitalization Sub-Fund.

You may redeem the shares held at any moment, by sending a request on any business day.

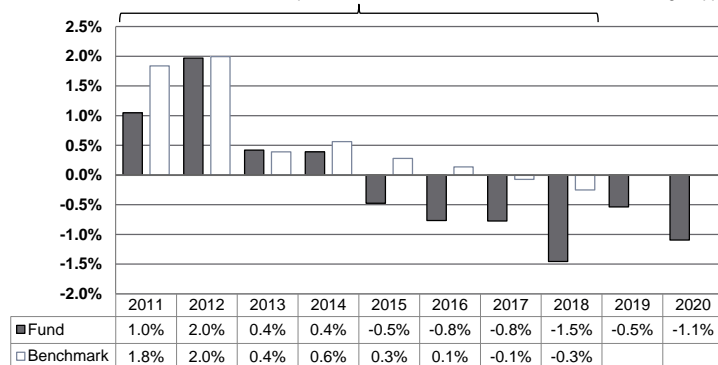
