## OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund has been categorized as an ESG Promotion Strategy Sub-Fund, as promoting, among other characteristics environmental and social characteristics, which are a binding component, for the assets selection and investment decision-making process, and the companies in which the Sub-Fund shall invest in need to follow good governance practices, in accordance with article 8 of the SFDR.

The Sub-Fund, expressed in Euro, aims at providing stable returns by investing primarily in investment grade short term securities issued by government and/or non governmental entities which comply with Environmental, Social and Governance ("ESG") criteria, with a flexible approach.

The Management Company's ESG criteria analysis incorporates elements of negative and positive screening alongside general and security specific Socially Responsible Investing ("SRI") / ESG-related analysis and ultimately, in alignment with the investment objective and policy of the Sub-Fund,

The detailed ESG criteria and exclusions applied are available in the Investment Policy of the Sub-Fund in the Prospectus.

The average portfolio duration of this Sub-Fund will not exceed four years. For the purpose of the Sub-Fund, debt securities will not have a residual maturity exceeding seven years.

The positioning of the Sub-fund in terms of duration and credit sensitivity would fluctuate, over the cycle, between two strategies:

the low risk strategy, which is more defensive, and the neutral strategy, with longer maturities, higher interest rate and credit risks sensitivity.

These securities may include, but are not limited to: corporate debt securities, bonds, fixed and floating rate securities.

The Sub-Fund may residually invest in securities denominated in currencies other than the reference currency of the sub-fund (EURO) and securities issued by entities domiciled in emerging market countries. The currency exposure will be hedged back into EURO. The Sub-Fund may also hold deposits. Moreover the sub-fund may invest in money market instruments up to 10% of its net assets.

The Sub-Fund may use financial derivative instruments for the purpose of risk hedging and for investment purposes. The Sub-Fund is suitable for investors who search short term investments.

The Sub-Fund is actively managed. The Sub-Fund is not managed in reference to a benchmark.

The Sub-Fund does not fall within the scope of Regulation (EU) 2017/1131 of the European Parliament and of the Council of 14/06/17 on money market funds.

This is a capitalization Sub-Fund.

You may redeem the shares held at any moment, by sending a request on any business day.

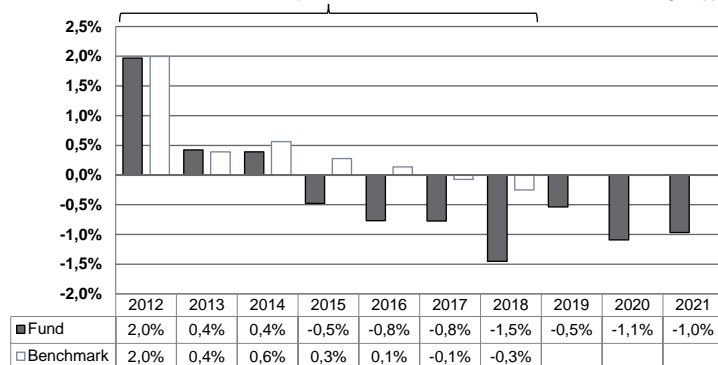
